- Accused Nos. 22 and 23 were discharged.
- Accused No. 9 was exempted on medical grounds.
- Misc. Appl. No. 12064 – Order passed for case against Accused No. 21 to proceed separately.
- Accused No. 22 has been declared absconding and notice under Section 82 Cr.P.C. has been issued.
