Dear Madam,

This is with reference to your letter dated January 29 & February 03, 2003 requesting the Exchange to furnish information regarding change of name from M/s. Euro Asian Securities to M/s. Home Trade Ltd.

In this regard, our reply is as follows:

1. The trading member vide letter dated August 25, 1998 intimated the Exchange regarding change in name from M/s. Lloyds Brokerage Ltd. to M/s. Euro Asian Securities Ltd. The Exchange vide letter dated September 01, 1998 forwarded original SEBI registration certificate of M/s. Lloyds Brokerage Ltd. to SEBI for incorporating new name M/s. Euro Asian Securities Ltd. SEBI issued registration certificate in the name of M/s. Euro Asian Securities Ltd. on September 09, 1998. The Exchange vide letter dated September 10, 1998 communicated the said change of name to the trading member and informed them to submit relevant documents for activation in the new name. Since they did not fully comply with the Exchange's requirements for activation in the name of M/s. Euro Asian Securities Ltd., the Exchange was unable to record the said name change on the system and did not permit the trading member to trade in the new name.
2. In the mean time, it was observed that M/s. Lloyds Brokerage Ltd. had effected change in dominant/majority shareholding without the prior approval of the Exchange which amounted to a reconstitution leading to transfer of membership. Accordingly, the trading facility was withdrawn by the Exchange on September 30, 1998.
3. The trading member vide their letter dated 18<sup>th</sup> February, 2000 submitted a copy of ROC certificate dated 24<sup>th</sup> November 1999 incorporating change of name from M/s. Euro Asian Securities Ltd. to M/s. Home Trade Ltd. The Exchange had noted the change in the name of the company to M/s. Home Trade Ltd. and vide letter dated May 04, 2000 approved changes in the majority shareholding of the trading member company i.e. Home Trade Ltd.
4. The application for seeking prior approval of SEBI for the said change in the majority shareholding of M/s. Home Trade Ltd. (formerly known as Euro Asian Securities Ltd.) was sent to SEBI on June 02, 2000.







5. Prior approval for change in majority shareholding of the trading member company was received from SEBI in the name of M/s. Home Trade Ltd. (formerly M/s. Euro Asian Securities Ltd.) on September 14, 2000.
6. Documents were sent to SEBI for fresh registration in the name of M/s. Home Trade Ltd. on October 20, 2000.
7. SEBI granted registration in the name of M/s. Home Trade Ltd. vide certificate dated November 10, 2000. There was a change in SEBI registration number from INB230597435 to INB230624638.
8. The trading member was informed vide our letter dated November 20, 2000 (Ref.No.NSE/MEM/368/7767) about the new registration granted by SEBI in the name of M/s. Home Trade Ltd. alongwith the change in SEBI registration number and also required them to submit relevant documents for enablement in the new name & code i.e. M/s. Home Trade Ltd.

As required, list of the documents is also enclosed for your reference.
