


P.W. No. 3 on S.A. :

1. On 11.05.2002, police requested us to act as a panch. I became to act as a panch. Then I went to police station alongwith police where bank officer by name Metha was present. At police station, police told us that they have to prepare panchanama about the seizure of bank document and I was told to read panchnama. Accordingly police seized documents, read over panchnama to me. I signed panchnama as panch on serial No.1. Panchanama (Exh-68) now shown to me is the same. It bears my signature. Its contents are correct. Police seized cheques register and other documents. Letter dated 28.06.2002 (Exh-69), bank statement from 01.04.2001 to 31.03.2002 (Exh-70).



4. It is not true to say that prior to this panchanama I acted as a panch in number of other panchanamas. I did not receive phone from any body on 11.05.2002. Nobody asked me to attend police station. It is not true to say that on 11.05.2002 I did not attend police station. I went to police station on 11.05.2002 as police called me. Police called me to act as a panch when I was stopped on bus stop. I went to police station around 1.30 p.m. to 2.00 p.m. It is not true to say that panchnama was already prepared I simply signed it. Except letter (Exh-69) and bank statement (Exh-70) I do not come across any document in court record seized during panchnama. Panchnama went on for two hours after 2.00 p.m. It is not true to say that today I am deposing false.


