ORAL ORDER

1. Rule. Ms. C. M. Shah learned Additional Public Prosecutor waives service of Rule on behalf of the State of Gujarat.

2. Present application is filed by the applicant-original accused for grant of temporary bail for a period of thirty days on the ground of treatment of his mother. Medical certificate is produced by learned advocates for the applicant-prisoner.

3. Hon'ble learned APP appearing for the respondent State and perused the documents and medical certificate produced on record before the Court.

4. In view of above circumstances, the application is partly allowed. The applicant-prisoner is ordered to be released on temporary bail from 15/11/2011

to 25/11/2011, on his executing a personal bond of Rs 5,000/- (Rupees five thousand only) and with one surety of the like amount to the satisfaction of the jail authorities and on usual terms and conditions.
